My dissertation examines the thematic maps of American Indian homelands, languages, and culture elements created in the past 200 years. Starting with a widely-used map, William C. Sturtevant's *Early Tribes, Culture Areas, and Linguistic Stocks* it utilizes a genealogical framework to trace the map's intellectual history, academic genealogy, and cartographic antecedents. I argue that social-scientific maps developed as part of a transatlantic circulation of ideas regarding natural science, philology, and the place of American Indians in the world.
